The Vet Meet Imaging Summer Camp 2019 takes place from 20<sup>th</sup> – 24<sup>th</sup> May 2019 on Lanzarote, Spain. It consists of scientific and social events (such as e.g. the scientific program, wine tasting evening, catamaran tour, volcano tour, parties) (the "**Summer Camp**").

1. I have been informed that Vet Meet - respectively their film team and photographers – are planning to film at the Summer Camp and to take photographs and sound recordings.

2. I hereby irrevocably and unconditionally:

2.1 consent to Vet Meet - respectively their film team and photographers – filming me, taking still photographs of me and/or sound recordings of my voice in connection with my participation at the Summer Camp and with interviews given by me during the Summer Camp (if any) and consent filming short parts of my lecture (if any) of up to 3 minutes, including my slides ("**my Contributions**", the respective footage, photographs and/or sound recordings the "**Materials**") and

2.2 consent to Vet Meet to use my Contributions, the Materials and/or any audiovisual or other productions based fully or partly thereon as often as desired in any and all media, procedures and systems, whether now known or hereafter devised, with no limitation as to time, territory and scope.

Without limiting generality of the foregoing, I expressly consent to Vet Meet

- to amend, cut, dub and/or synchronize my Contributions and/or the Materials and/or to combine them with other works, and/or
- to use them (also in amended or shortened form) for the production of any audiovisual productions (including but not limited to a "making-of" of the Summer Camp and promotional clips and films) and/or for the production of any other promotional material (including but not limited to leaflets, flyers, brochures) (any production based fully or partially on my Contributions and/or the Materials the "**Productions**"), and/or
- to exploit my Contributions, the Materials and/or Productions as often as desired in any and all forms, e.g. to make my Contributions, the Materials and/or Productions publicly available over the internet (including but not limited to making them available on the Vet Meet website or via social media and including but not limited to all forms of streaming and downloading), to copy them (e.g. also on analogue and digital video, sound and data carriers of all kinds), to distribute them and/or any video, sound and data carriers, to broadcast them, to exhibit them, to use excerpts, to amend and adapt them and to directly or indirectly promote and/or advertise Vet Meet, Vet Meet's products, services or events and/or Vet Meet's partners and sponsors.

3. In addition, Vet Meet is also entitled to use any of my remarks about Vet Meet and/or the Summer Camp (e.g. in the final survey) (in the following also "my Contributions") as described under 2.
4. Should my Contributions be protected by copyright or neighbouring rights, I also herewith assign to Vet Meet by way of assignment of present and future copyright and neighbouring rights, the rights to use my Contributions, the Materials and/or Productions as described under 2.
5. I acknowledge that Vet Meet will not be obliged to use my Contributions.
6. Should Vet Meet decide to use my Contributions, Vet Meet is entitled but not obliged to state my name.
7. I acknowledge that Vet Meet may at any time assign or sub-license any permissions and rights granted herein.
8. I acknowledge that I will not receive any payment for the grant of permissions and rights contained herein and/or for their exploitation.
9. Should any provision of this agreement be or become invalid or unenforceable in whole or in part, this shall not affect the validity and enforceability of all other provisions of this agreement.
10. The validity, construction and performance of this agreement shall be governed by and construed in accordance with the law of Germany. Each party irrevocably submits to the exclusive jurisdiction<sup>1</sup> of the courts of Germany over any claim, dispute or matter arising hereunder or its enforceability.
